President's Message by Paul Guffey

At my writing this article, the General Assembly has acted on only a few pieces of legislation and none of much significance to KPR. But with the General Assembly in session, things can happen at any time. Meanwhile, our legislative liaison and our legislative agent are busy monitoring the status of selected legislation that would impact our organization. Additionally, calls for your involvement have been going out when needed, and I am pleased to report that many members have been contacting their representatives and senators urging appropriate action. That is what we must do particularly while the Legislature is in session. Thank you for being active!

Now, allow me to provide a brief update of PR activities that are being supported financially by all chapters. Robin Hartman, our contracted public relations/marketing provider, is becoming familiar with KPR's mission and goals. One of our main goals is recruiting members and that involves using the media to get information out about our organization. We have to use all the media available to communicate since prospective members respond to different media, be it newspaper, radio, TV, emails, texting, the internet or Facebook. We are trying to tap into the media in a broad approach to appeal to public service retirees. Robin has developed radio and TV interview opportunities, prepared editorials, and newspaper ads. Word about us is getting out to the public.

What can you do? You can continue to do what has proven to be the most effective way to recruit new members: talk to the retirees you know and provide them information about the condition of the KRS pension funds and the need to have more members! Tell them about our website, Facebook page and about chapter meetings. With your help, they can become informed. Thank you for your active support and for faithfully paying your membership dues. Paying those membership dues makes our " KPR world go around."



Legislative Report by Shirley Clark, Legislative Chair

March 7 completed 41 days of the 60 allowed for the General Assembly, and as of this date, very few of the 800 plus bills have actually been signed into law.

Bills that could be beneficial to retirees and others that could be detrimental have been introduced, but as of this date, they have moved very little or not at all. HB 235, which contains the 100% actuarial contribution required by KRS for full funding, is currently in committee after having had readings and has been returned to the Appropriation and Revenue Committee for hearings. We must continue to work to assure the funding remains in this bill. This is our #1 priority.

There seems little or no interest in making any changes to SB 2, the pension reform bill, which passed in 2013, however, the Senate may have other thoughts on the issue of transparency and spiking in SB 142. Of particular interest is HB 324, the KRS housekeeping bill, with the KPR requested floor amendment regarding the replacement procedure of elected KRS Board members if there is a vacancy of someone on the board. This bill was sent to the floor for a vote on February 18, and remains there. We have asked that calls be made in support of this bill with the HFA (1) amendment, and we hope that has been done.

The dedicated funding, which we would like to see in bill form, changes to SB 2 on retirement items, and COLA provisions have had nothing or very little done so far on them; and it doesn't look like it will be done. Two bills have been introduced requiring funds to be used for the unfunded liability. HB 68, the gaming bill, has had no hearings on it as of this date. HB 137, requiring sales and use tax collected from out of state sales, passed out of committee, but was recommitted to the Appropriations and Revenue Committee, which usually means it is dead.

The KPR web site has been greatly improved by the new administrative manager. All of the bills we are following, supporting, or opposing are now listed on the KPR web site. Each day it is updated when changes are made in the session. There are links to go straight to information on your legislators for contacts to be made. Since by the time you receive this Kernel, changes to bills will have taken place, please keep up with the undated information on the web site. For those of you without computer access, your chapter legislative chairs and presidents should be keeping you updated by phone or other methods. It is so important to call your legislator when the word is sent out about supporting or opposing a bill.

Thus far this year, the alert system has not been used much, but we anticipate it will be used more as we get closer to the second half of the session. Go into our web site, www.kentuckypublicretirees.org and place your email on the home page to be able to receive these alerts. This would also be a great time to sign up new members. Let them know what is going on, and the importance of full funding remaining in the budget bill. Convince them to join our organization with free dues for the first year.


Membership Article by Betty Hawkins, Membership Chair

He gave us tips on how to avoid becoming victims of scams, fraud, and thefts. In January, Larry Totten and Mary Helen Peter, KRS Board of Trustee candidates, spoke with our group. Each spoke of their background, qualifications, and goals if elected as trustees. At our December meeting, Sara Beth Gregory, Kentucky State Senator, spoke with our group regarding the state of the retirement system.

On January 8, 2014, we hosted the candidates for the two KERS Board of Trustees positions to speak at a candidate forum sponsored by the chapter. The remarks and the Q & A session following were videotaped and posted on our chapter's Facebook page (<https://www.facebook.com/NCKPR>). On Wednesday, February 12, our speaker was Chris Tobe, former member of the KRS Board, and noted whistle-blower. He spoke on KRS and Kentucky's pension system problems. His videotaped remarks were also posted on Facebook. Other chapters are welcome to attend any of our meetings.
