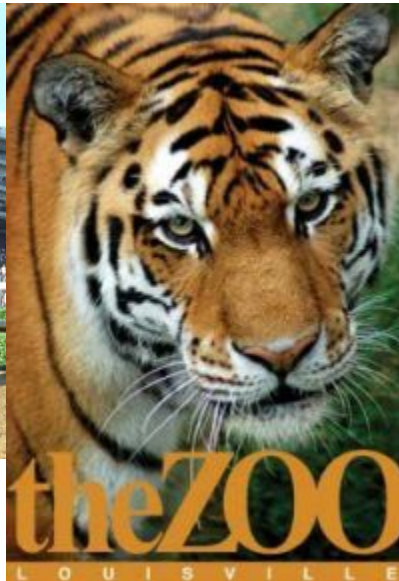

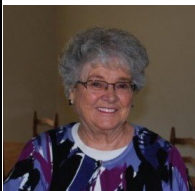

But to be effective members of KPR and even effective at navigating the complex choices of health insurance coverage, it is necessary to learn and keep informed. This learning and developing includes using computers.

Where I sit writing this article, several things have computerized operations. Currently only 66% of KPR membership have provided us email addresses; email usage must increase. The organization cannot afford print and mail.

On a lighter note, it's helpful to take breaks from stressful issues to relax, enjoy social events, renew acquaintances and simply have fun! The annual conference scheduled for June 12 and 13 will provide these wonderful opportunities. I look forward to seeing you.



Legislative Report by Shirley Clark, Legislative Chair

The 2014 Session of the General Assembly ended as it most often does with many disagreements and debates still unsettled at midnight on April 15. The speaker at the Bluegrass West meeting in April made a statement that I believe is worth repeating: "Sometimes you can tell more about the success of a session by looking at what didn't pass, rather than what did." And this year, that may be true for retirees.

The major goal of KPR, which advocated the full funding required for our retirement system, passed in HB 235, the Executive Branch Budget Bill. During the next two years, we hope to see some relief in the unfunded liability of the system. HB 5, a bill that requires public agencies and others to notify persons impacted by security breaches of personal information within 72 hours of the breach was passed, also HB 232, a bill requiring consumer notification when a data breach reveals unauthorized personal identifiable information passed.

These three bills were the only bills passed affecting retirees. Two resolutions, HB 29, which supported legislative action to fully fund the system and HB 30, which would have provided a dedicated revenue source to fund the system, passed unanimously, but resolutions do not have the full force of law.

Bills KPR supported that did not pass are the following:

- HB 324 (The bill we made so many calls on) which would have allowed elected KRS trustee member vacancies on the KRS board to be filled by elected members rather than all of the board members.
- There were no bills passed that would have appropriated dedicated funding to the Retirement System in future years. There were bills that would have allowed this; among them were HB 68, HB 137, and others.

- HB 323, which would have placed two retirees and two state employees on the Pension Oversight Board in addition to adding more agencies under the review of this board, did not pass.
- SB 5 and HB 48, the transparency bills which would have required disclosure of retirement income on the KRS web site, did not pass.

There were no tax bills introduced that would have caused retirees to begin paying taxes on their retirement income. Although this was not a topic discussed much during the session, we are very glad it wasn't. We will still have to be very diligent in watching for this to happen in the future.

We will not receive a cost of living adjustment (COLA) for the next two years. Although we tried, it was not an option of discussion by legislators.

Our members throughout the state worked very hard in making calls, emailing, and other contacts to their legislators and the Governor to oppose and support certain bills. It paid off in the long run since the full funding was approved. Without this passing, our system's unfunded liability would continue to increase.

Sarah Hurst, Legislative Agent and I would like to thank all of those who made the thousands of contacts during this session of the General Assembly. There were 824 bills introduced this year, and approximately 124 were passed. There were also 560 resolutions introduced.

Retirement Article by Shirley Clark

The Board of Trustees of the Kentucky Retirement Systems held their annual meeting on April 17, 2014, in Frankfort. Mary Helen Peter and Vince Lang, newly elected board members of the Kentucky Employee Retirement System (KERS) were sworn in. Randy Stevens also was sworn in to fill the County Employee Retirement System (CERS) position by appointment of the Governor. This appointment came about due to SB 2 adding new CERS board members. This recommendation to the Governor came from the Kentucky Association of Counties.

New officers of the board were elected. Thomas Elliott of Louisville was elected Chairman of the Board, and Dr. Daniel Bauer of Louisville was elected Vice Chair. Four candidates had applied for the vacant CERS position which is currently filled by the remaining members of the board. William Summers of Louisville was elected to this position.

A progress report was given, and some of the pertinent information from it was that the Investment Fund performance has continued to improve. The pension interest rate return for 2013 was 13.3% compared to 12.7% for the previous year. The insurance rate was 13.2% compared to a 12.3% rate last year.

There are currently 340,626 members of the KRS system. CERS makes up the largest system covered with 61% of membership. The fund pays out \$2.2 billion each year to retirees with the largest amounts going to Jefferson County (\$300 million), Franklin County (\$181 million), and Fayette County (\$93 million). The defense of the bankruptcy action by Seven County Services has cost approximately \$750,000 thus far.

The State Police Retirement System will need to elect a new member next year, as Randy Overstreet's term is up, and he has served the maximum length of time he can serve. Applications for the position must be received by KRS by July 31, and the ballots will be mailed out in mid January of 2015. Details of this election will be posted on the KRS web site. Beginning July 1, Larry Totten will be handling the duties of the KPR retirement liaison. He is an active member of the Bluegrass West Chapter, is very interested in our retirement, and attends all retirement board meetings. He will do a great job. I personally want to thank Larry for volunteering for this job.

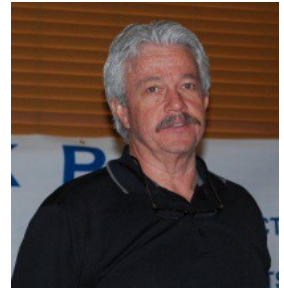


Membership Article by Betty Hawkins, Membership Chair

Our state membership contest ends in less than six weeks (May 31, 2014). Your continued membership in KPR is vital to our continued success.** Participation in local chapter activities is not required for membership because we realize individual circumstances dictate the amount of time people have to devote to KPR activities.

We are very pleased to announce an additional chapter will be formed in Eastern Kentucky. The first organizational meeting was held in Jackson, Kentucky (Breathitt County) on March 25, 2014, with 45 people attending. This chapter will cover the counties of Breathitt, Lee, Magoffin, Morgan, Owsley, Perry and Wolfe. A very special thanks to Cumberland Valley Chapter members Jerry Connell, John Harris, David Cornett, and Carl Lawson for assisting in this effort. David Cornett, CV Chapter Legislative Chair and former native of Breathitt County, is primarily responsible for the success of this effort. From January 1, 2014, through March 31, 2014, over 106 new members have been recruited. Membership numbers are updated at the end of each month, and these numbers are continuing to grow. ***Kudos to David Cornett for this superb effort.*** All new members in this area will be periodically updated as these organizational efforts move forward.

Barren River The chapter met March 17, 2014, at the Barren River Area Development District Office. President, Les Settle called the meeting to order, welcomed new members and guests, and thanked all for attending. Stan Markham, long-term care specialist with Bratcher Financial, was introduced. He spoke to the group regarding options and how to pay for long-term care. He discussed Medicare, Medicaid, and the length of time one might spend in a health facility. He noted the nursing homes in Bowling Green and Glasgow and the assisted living facilities. He said that many are now using Home Instead care. He commented that people are now living longer with the help of doctors. After a question and answer session President Settle thanked him for taking time to talk to the membership and answer questions.

Bluegrass West The chapter met on March 18, 2014, and the program concerned the status of 2014 legislation. Representative Derrick Graham, guest speaker, spoke about the status of the various bills affecting retirees. State Legislative Chair Shirley Clark and Sarah Hurst, Legislative Agent, provided more specific details concerning the current position and status of the legislation. Both Ms. Clark and Ms. Hurst relayed their appreciation to KPR members for their continued contact with members of the General Assembly. State Auditor Adam Edelen thanked the entire statewide network of KPR members for their support of HB 5.

On April 15, 2014, Shawn Sparks, Director of Constituent Services for KRS, provided members information concerning the impact of 2014 legislation upon KRS. He said the passage of HB 235 fully funded the ARC during the upcoming biennium. Mr. Sparks also responded to specific questions from chapter members. The BW Chapter will not be holding their regular chapter meeting on May 20 since this is Primary Election Day. The next regular monthly meeting will be on June 17, 2014, at which time we will have our annual election of chapter officers and present our Bluegrass West Chapter Waterfield Awards.

Covered Bridge On April 10, 2014, Rick McHale, a representative from Humana, talked to us about the Humana Rewards Program. A nominating committee was established for new officers for the coming year. Also, we are trying to recruit members from adjoining counties. To recruit members in Menifee County, we will post a flyer on the bulletin board of the Menifee County Courthouse. We have contacted recent retirees and members who have failed to pay their dues.

Cumberland Valley The Cumberland Valley Chapter met in the Bell County Public Library in Pineville on March 11. The meeting consisted of a group discussion about all legislative bills concerning our retirement. Members were encouraged to email or call their senators and representatives supporting our need. A nomination committee was appointed for the chapter election in May.

On March 25, four members from CV, along with President Guffey, V.P. Clark, and Membership Chair Hawkins, traveled to Jackson, Kentucky to help establish a new chapter in that area. At our April meeting, our guest speaker was Nancy Burchett, a technical expert from the Corbin District Social Security Office. Mrs. Burchett gave an excellent presentation on eligibility for Social Security and Medicare. David Cornett gave an update on several pending house bills.



Our May meeting is planned for May 13, at The Golden Corral in London. We hope to have an APPOINTED member of the KRS Board of Trustees as our speaker. Our annual election will be held, and members have been advised they must be present to vote.

Green River We did not have a guest speaker for our March 12th meeting so that we could devote extra time to general business and legislative issues. Lewis Jean, our Legislative Chair, gave a comprehensive report on pending legislation that could possibly affect our membership and suggested that everyone follow the legislative reports on the KPR web page. We also discussed other information and useful links available on the web page.

Our guest speaker for the April 12th meeting was Schley Cox who is associated with the Senior Medicare Patrol. This is a community outreach program operated by the Green River Area Development District to help Medicare recipients better use the program and identify problems and fraud. The program provides speakers and Medicare claim expertise to senior groups, health fairs and other interested groups. The majority of his presentation dealt with current scams and shady telemarketing practices.

Jefferson Regional On March 5, 2014, Rick McHale joined us to explain Humana's Vitality Program which is offered to Medicare eligible members as an incentive to stay healthy. It involves a partnership Humana has with Walmart in which a vitality card works as a 10% discount on future healthy food purchases. In addition, Humana is offering wellness home visits by a physician who visits the member in their home to do a wellness assessment. Also, their Guidance Center in Louisville is open daily and is senior-focused with programs that include a free Spanish class. Mr. McHale and Stephanie Heller will have a table set up at the Annual Conference and Ms. Heller is on the agenda to speak. Nikki Henderson, President, asked members to consider supporting HB 5 by contacting their legislators, along with HB 324 regarding the replacement of ELECTED members on the KRS Board of Trustees when there is a vacancy in one of the CERS KERS and SPRS positions.

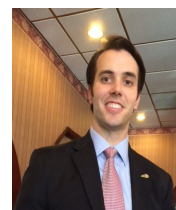
